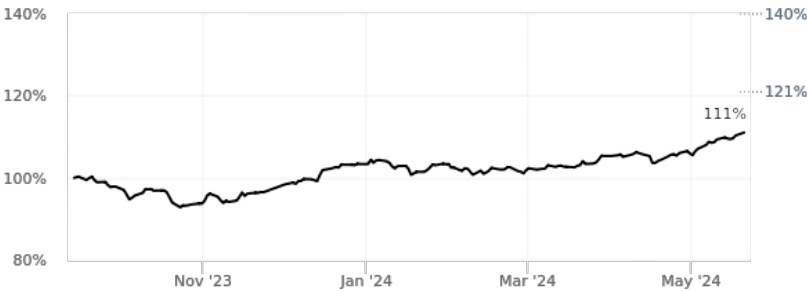

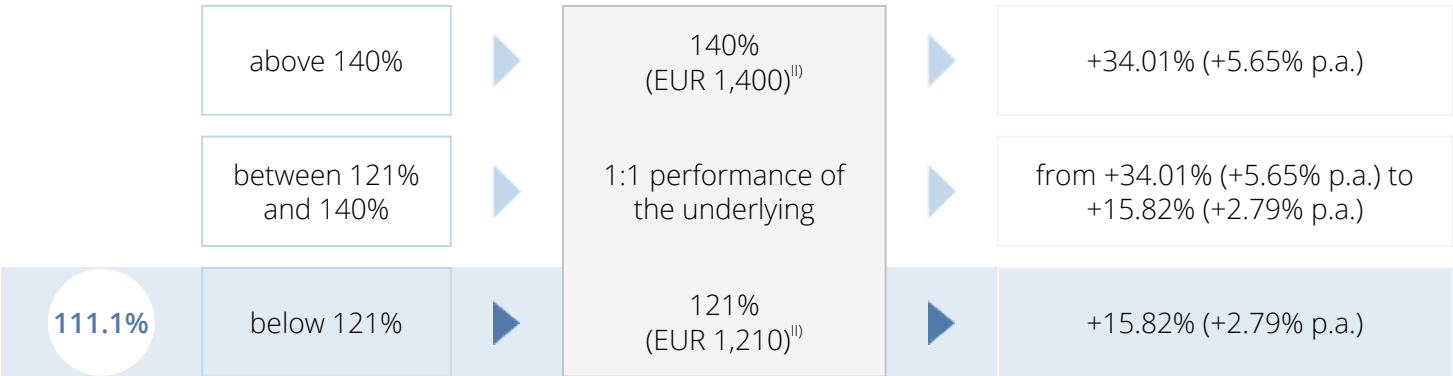

### The Underlying

### Functionality

At the initial valuation date the starting value of the underlying and at the final valuation date the final value is determined. At the final valuation date the closing price of the final value is compared to the starting value and one of the following scenarios will apply:

1. Final value  $\geq$  140% of the starting value → Redemption at 140%  
If the final value is greater or equal to 140 % of the initial value, 140% of the nominal value is paid out on the redemption date. This also represents the maximum redemption (maximum amount).
2. Final value  $\geq$  121% and  $<$ 140% of the starting value → 100% Participation  
If the final value is greater or equal to 121% or less than 140% of the starting value, certificate will be redeemed on the redemption date according to the performance of the underlying (percentage development from the starting value to the final reference value).
3. Final value  $<$  121% of the starting value → Redemption at 121%  
If the final value is less than 121% of the initial value, 121% of the nominal value (capital protection) is paid out on the redemption date.

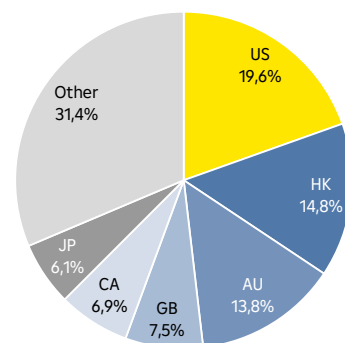
