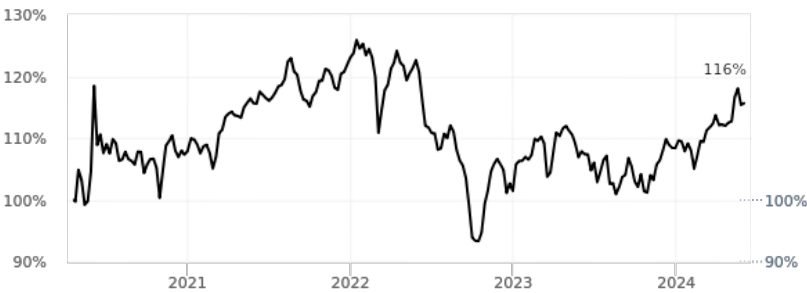

The Underlying

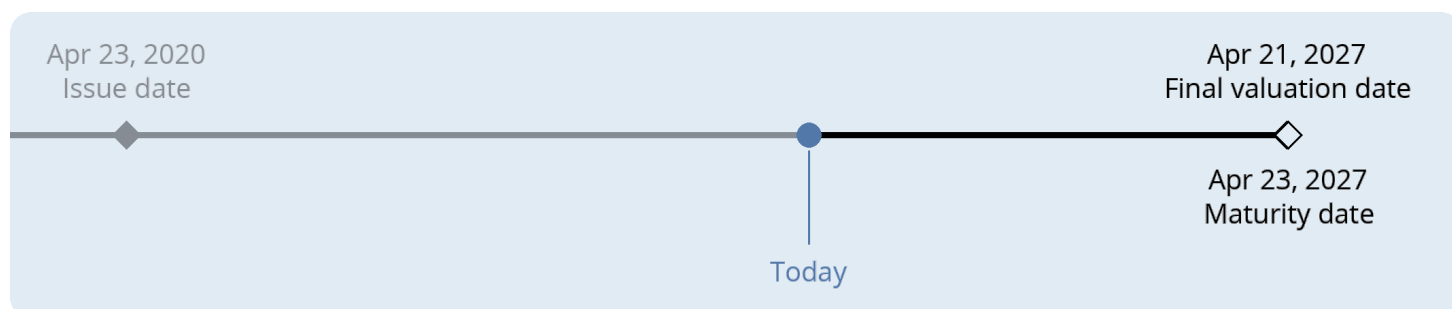

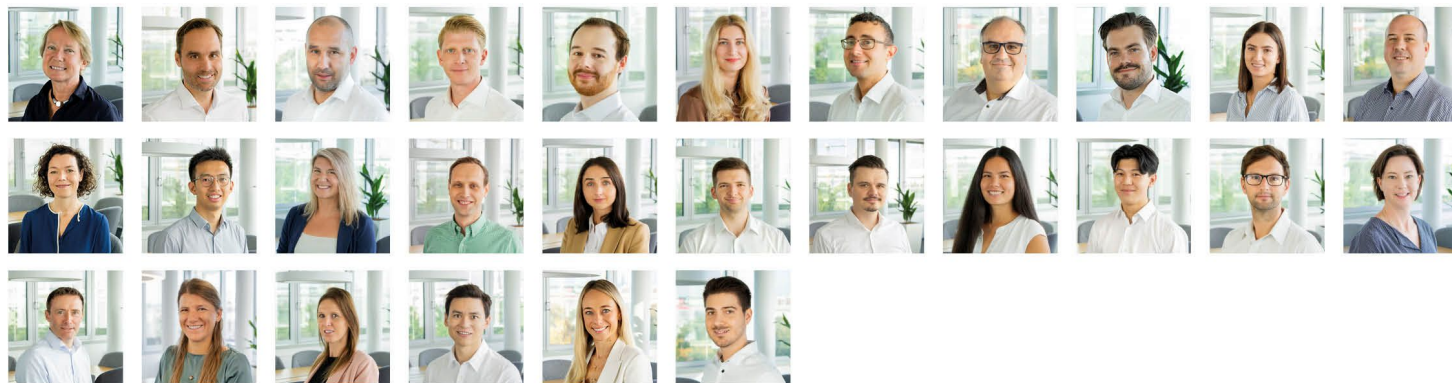
