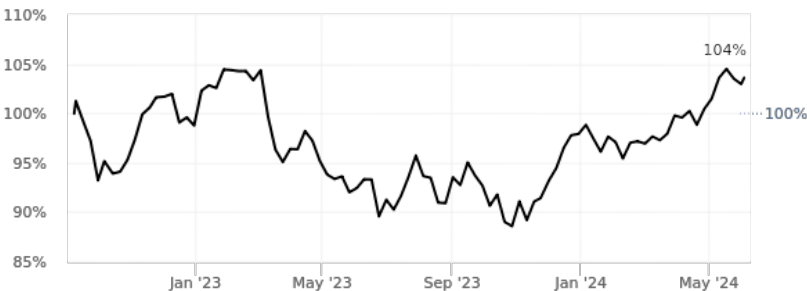

The Underlying
