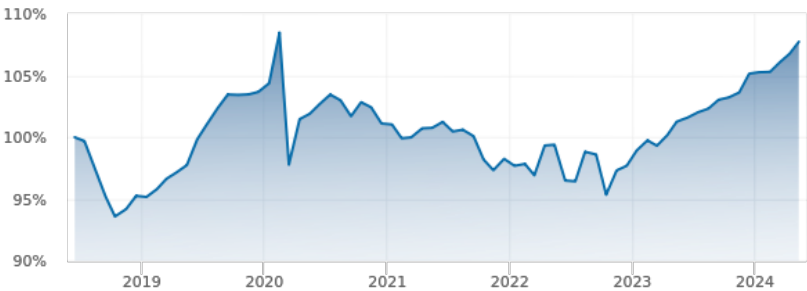

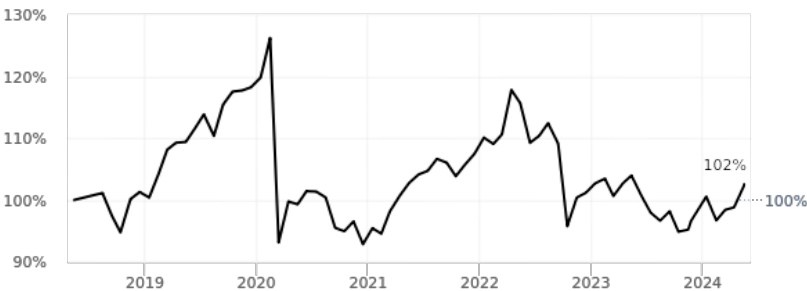

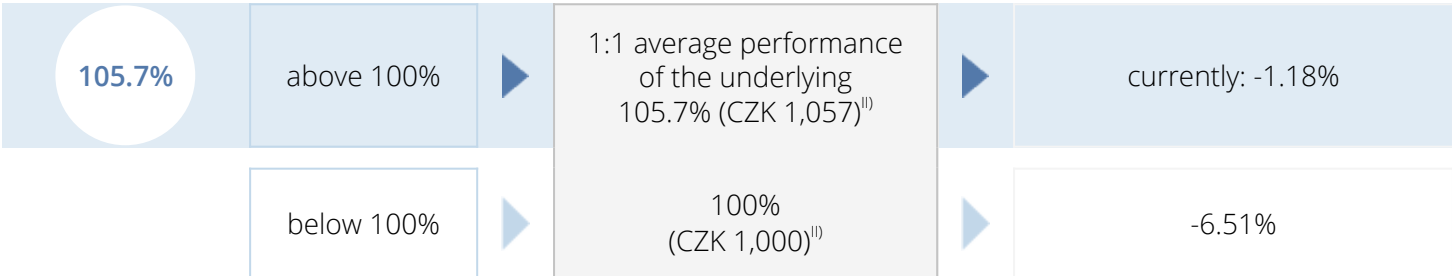

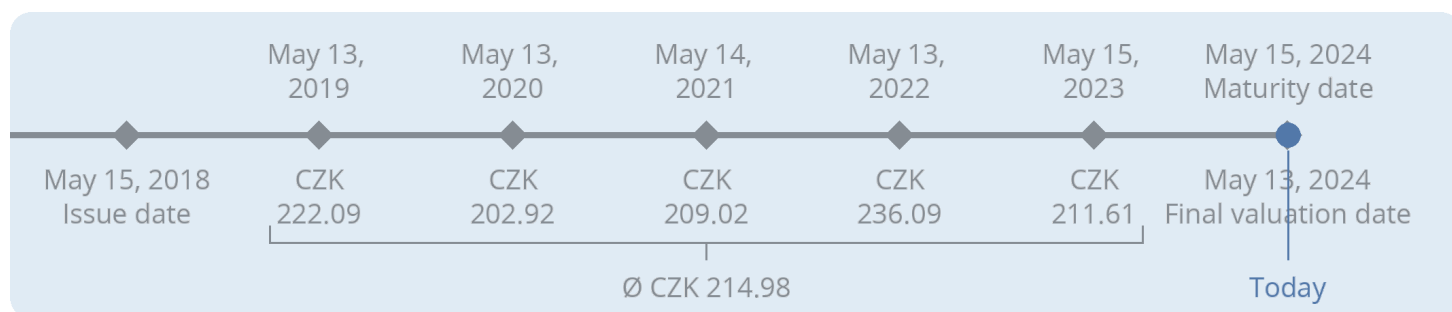
### The Certificate
