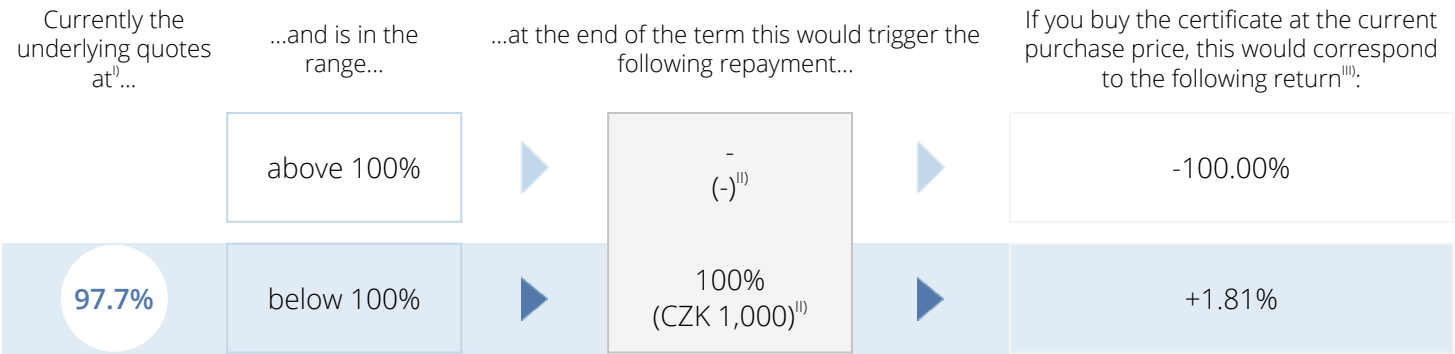

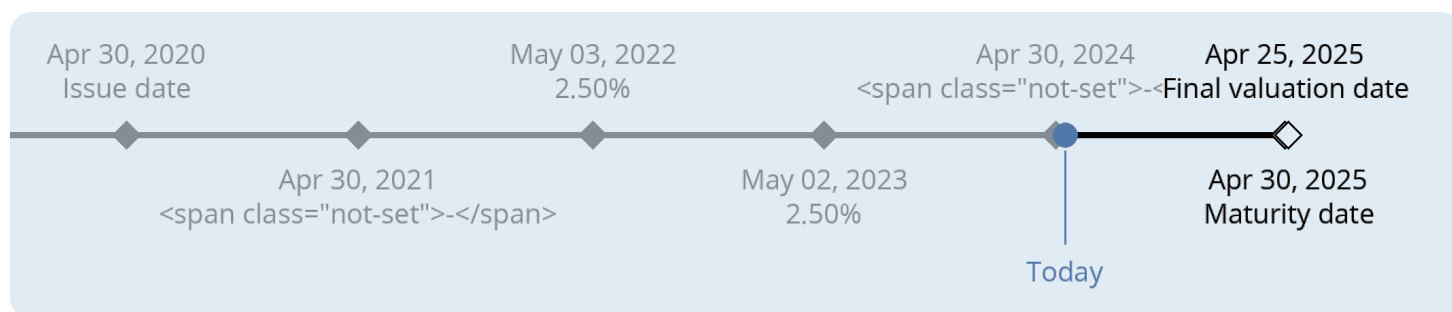
### The Certificate
