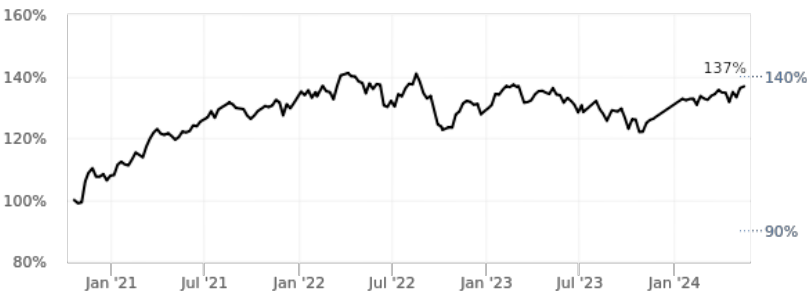

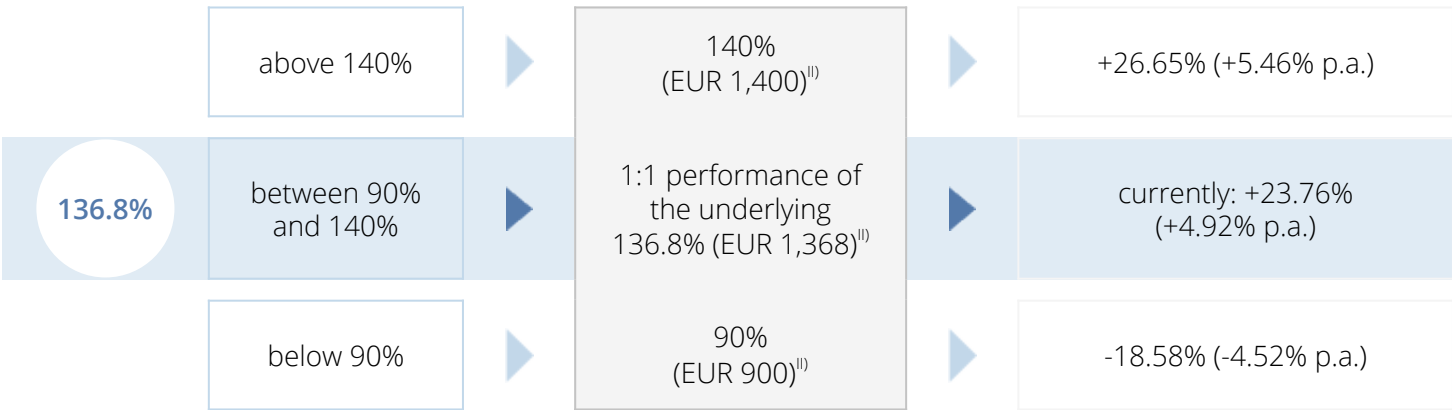

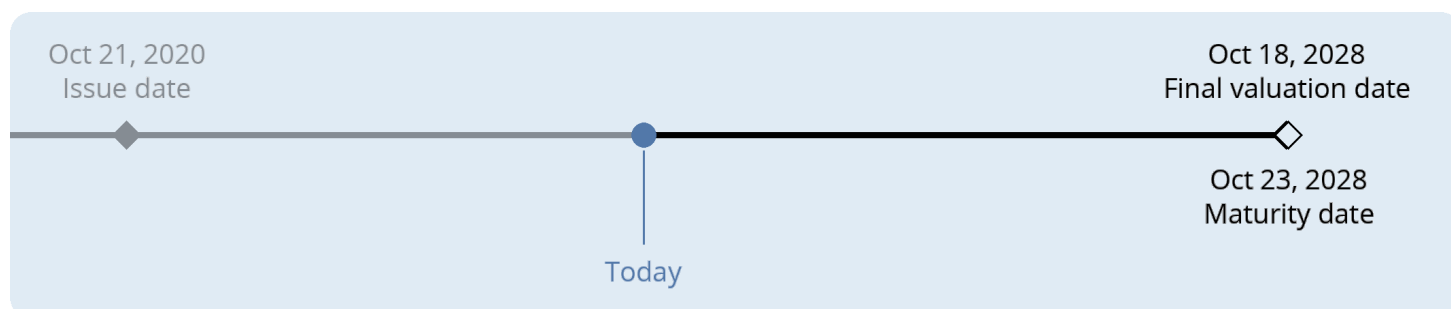

## The Certificate
