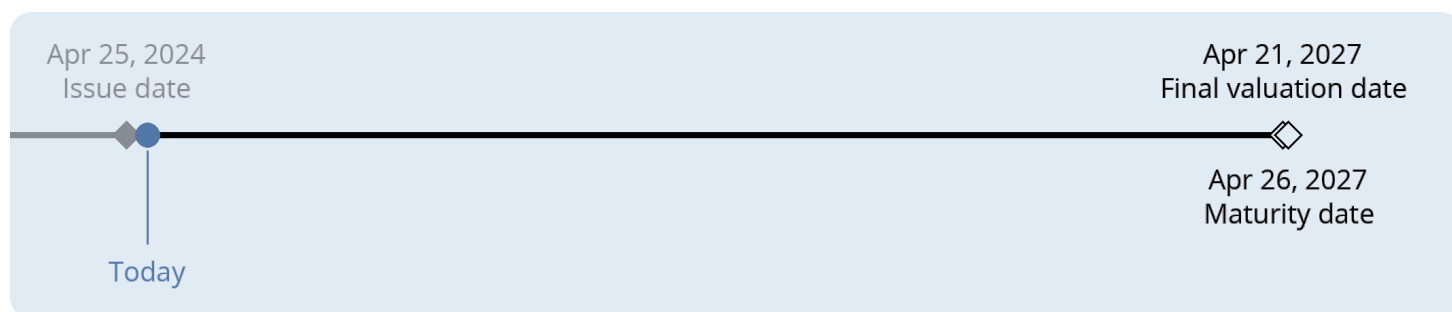
### The Certificate
